Each part was followed by interesting discussions with the public on this extremely important topic which is central to the present and the future of Futures Studies

- 1) Report by the General Secretary Peter Menke-Gluckert The General Secretary reported on the status of the WFSF which is formed of 201 Members of which 17 are institutions He reported on activity initiated by the WFSF in the last year since the March 1974 General Assembly This activity will be described in the Action Programme for 1975 (see item 4 of Agenda) The formal contact with the Zentrum Berlin fur Zukunftsforschung was also reported upon, from which emerged the resolution to organize a one-day conference on "Social Minimum and Social Maximum" on the 30th of May 1975 prior to the General Assembly The possibilities of contact for WFSF with UNESCO specifically as a research input on the "Human rights project" were outlined Reference was also made to the pamphlet distributed at the General Assembly containing other details relevant to the report. The Pamphlet contains objectives, statutes (as adopted in Paris on May 26, 1973 and established in conformity with French legislation and relevant to the "association dites etrangeres") activities, plus the list of officials elected at the Paris General Assembly March 29-30, 1974 The General Secretary also reported that the Executive Board met four times during the last year in Paris, Amersfoort, Dubrovnik and Berlin and the General Assembly twice (March 29/30, 1974, May 30/31, 1975)

The Scientific Council met once in Dubrovnik The budget as it stands at May 28th 1975 was approved (see annex 1)

The General Secretary also confirmed that the WFSF will continue to be in the jury of the Berlin Film Award "Prix Futura" recommending a new film award for films on intermediate technology produced in developing countries to face problems of the developing countries

#### themselves

He ended the report with his resignation and recalled the feeling of friendship which has been developing in the WFSF in the last few years. The President, Johan Galtung, thanked Peter Menke Gluckert for all his unstinting work in the last four years.

## 2) The Report of the Credentials Committee

The Credentials Committee, as elected in Paris in 1974, presented its report through Serge Antoine as Chairman on 30 May 1975 (see annex 2) On the first part of this report (Scientific Council Members) two corrections were made during the Assembly A Kojarov is an individual member and A Beer has confirmed his position as member of the Council To this Scientific Council (now 40 Members) the Credentials Committee on request of the Bureau asked for the addition of 19 Members (see annex 3)

The Credentials Committee's report was accepted by the General Assembly in connection with the by-laws (on the Credentials Committee's report, also see item 7 of Agenda Election of Officers)

#### 3) Continuation of WFSF

On this item the General Assembly voted immediately (14 - 0 - 0) R Jungk pointed out the reasons for the past of the WFSF and underlined the ones relevant to its continuation to be a liaison organization for those working in the field of future studies and to be a means of interrelation among countries of various regimes To these S Antoine added a precise orientation that

- a) permits organizations and institutions to work together and to understand the reason for their support of the WFSF,
- b) facilitates a structure which is really decentralized,
- c) inserts the WFSF among other international organizations in a system of better relations

At this point a general motion of warm thanks was approved by all the present members of WFSF to Stella Tracey, who has hither-to been working in Paris at the Secretariat

4) Action Programme

The action programme presented the following sub-items

- A) A Newsletter, with the function of developing a network of intercommunication among the members of the WFSF and between the WFSF members and other centres and individuals, was approved. It will be edited by IRADES, Institute for Futures Research and Education as a separate part of its Newsletter under the name of "Newsletter WFSF". It will work in close contact with other journals (Futures, Technological Forecasting and Social Change, Analysen und Prognosen, Futuribles, 2000, etc.)
- B) A Future Forum Bill Board project was also approved which will stimulate the new or just emerging ideas in the field of futures studies so that people interested or working on them can come into contact. This was approved
- C) The Conferences proposed for next year were discussed
- a) 5th World Conference to be held in Dubrovnik from 28th March to 2nd April with two specific topics
  - 1) "World alternatives systems versus needs",
- 2) "Education in the Future, education towards the future"
  The preparatory committee will discuss and prepare an agenda in which over and above the two main topics, other topics will be discussed in an open day Specifically one was decided upon "philosophical and ethical foundations for futures research" and specific workshops will be held according to the interests arising during the General Assembly and which are received in the next few months from the members of the WFSF This was approved

It was also proposed that one of the preparatory committee's meetings should take place in Warsaw

- b) A meeting in Berlin is proposed to be held at the ZBZ on "social minimum, nutrition minimum, habitat minimum, educational minimum" at the end of November 1975
- c) A meeting on "education in the future" will be  $\mathbf{h}_{e}$ Id on 10-13 January in Partinico at the "Centro Educativo" directed by Danilo

Dolci, which will also provide an input in the Dubrovnik conference on this topic

- d) It is also expected that a Conference on "the future of religion" will be held in Rome in the Spring of 1976
- e) A meeting on "global modelling" will be held in Mexico in Autumn 1976, and its specific topic detailed
- D) Two centres work under the auspices of the WFSF
- a) The Bucharest International Centre of Methodology for Future and Development which is able to have students for periods of study,
- b) The "Centro Educativo" of Partinico where people interested in innovative education may live and work

Other centres were proposed and will be taken into consideration for cooperation

- E) Three schools/courses are conducted in cooperation with the WFSF a) The International University Centre of Dubrovnik course on futures studies, which this year had E Masini as its director and B van Steenbergen as its co-director, will continue next year from March 15 to April 9 and be directed by B van Steenbergen
- b) The course lasting six months at the College for the Future In Denmark, Handerslev directed by Arne Sorensen where students may live in and which will organize winter courses in English and Danish c) "La Scuola di studi sul futuro" IRADES has held two courses of two months during 1974-75 and will continue in 1975-76 directed by E Masini The meetings for Italian university students and university students from developing countries and the meetings for high school students will also continue as in 1974-1975
- F) Research by WFSF members will be coordinated by the ZBZ as coordinating centre. The researches envisaged are
- a) needs research, material and non-material
- b) alternative life styles in various countries
- c) foundation for futures studies (theoretical, methodological, philosophical, ethical) (see also annex 4)
- d) world indicators

- e) futures of political and administrative systems
- It was requested and accepted that the ZBZ, of which O Flechtheim will be research coordinator, will prepare a proposal for the coordination of the research to be presented to the WFSF Executive Board The Claude Nicolas Ledoux Foundation will continue to give the World Future Studies Federation its support in the following form
- By making available to the Federation a part of its premises in Paris, at 55 rue de Varenne, where the Federation's heal office is situated. The archives relating to the constitution of the Federation and the rooms necessary for the work of the Credentials Committee will be provided there.
- By opening the Centre International de Reflexions sur le Futur, situated in Arc-et-Senans in France for meetings, and courses organized by the Federation or its members, charging special rates for the Federation

But above all it will continue its efforts, announced at the 1974 General Assembly, to

- collect knowledge of experimental work and social innovations making it possible to understand better the response to social needs and aspirations, and the differences in life styles,
- collect materials and expressions of the future and of the future dimension in pedagogy (books for young people in particular),
- finally with the journal "2000" and "Future Information" it will provide French-speaking readers with information on the WFSF and by its members (see item 4 sub-item A on Newsletter)
   The action programme was accepted en bloc
- 5) The statutes, by-laws, membership dues
  The statutes (\*) corrections were approved in
- a) point 1, sub-point 3, last item read "assisting relevant national and international future research activities",
- b) point 6, General Assembly, sub-point 5, read "No decision may

be taken without at least a two thirds majority of the members present"

The by-laws were approved (see annex 5)

Membership fees were accepted as 30 dollars for individuals and 200 dollars for institutions or the equivalent in foreign currency, the Secretary General having the discretionary power to grant exceptions A finance committee was approved with A Ferrari Toniolo accepting to cooperate with a member of the Swiss Association and of the German Association The assets and accounts will be transferred to Rome at the end of September 1975

RECOMMENDATION OF THE WFSF GENERAL ASSEMBLY TO INITIATE AND SUPPORT WORK ON THE ETHICAL FOUNDATIONS FOR FUTURES STUDIES ACTIVITIES AND FOR SCIENTIFIC WORKERS INVOLVED IN SUCH

Today, "Futures Studies" are considered more important by some people while they are being rejected by many others because of the "hidden" implications and influences of these activities. As a WFSF we must be interested in acknowledging such difficulties and in helping to clarify the position of the people involved in futures studies. By the concept of "the future", the Federation means the totality of the world's future societies, including all social, economical and political systems and sub-systems and the relationships among them, including the changes and development of potentialities in man at the biophysical, psychological and spiritual level

Hence futures studies, as they appear today, is a field of intellectual and political activity concerning all sectors of the psychological, social, economic, political and cultural life, aiming at discovering and mastering the extentions of the complex chains of causalities, by means of conceptualisations, systematic reflections, experimentations, anticipations, and creative thinking Futures studies therefore constitute a natural basis for subnational, national and international, and both interdisciplinary and transdisciplinary activities tending to become a new forum for the basis of political decision making

The Federation stresses the importance of promoting phisosophical research on the fundamental concepts and ultimate aims of futures studies, in order to establish a conceptual and ethical basis if possible capable of being applied by all scientific workers engaged in futures studies, irrespective of their field of specialization, legal status of underlying motivations or the immediate application of their work. The focus of this effort should be to

- clarify each generation's responsibility and limits of responsibility towards future generations,
- identify problem areas, objectives and priorities for futures studies activities,
- clarify the obligations and responsibilities the scientific worker

engaged in the field of futures studies has as a political actor in the future societies of the world.

— stress the need for each person in futures studies to state clearly his basic values, and the underlying presuppositions in his work. The WFSF General Assembly asks all members of the Federation to support and to contribute to this work, to elect the members of a steering committee, with the responsibility to initiate and coordinate this work, and to present as a basis for further investigations, a preliminary conclusion to the 5th World Conference of Futures Research in Dubrovnik in Spring 1976

# BY-LAWS OF WORLD FUTURE STUDIES FEDERATION

§ 1

The by-laws interpret the statutes for the purpose of facilitating membership participation in activities and formal proceedings of WFSF decision-making bodies

# § 2

The Credentials Committee reports in writing to General Assemblies regarding membership development including candidates for the Scientific Council Prospective members are in principle invited to join the Federation by sending a written application, including credentials and a list of major publications and future research activities Applications have to be sent to the Secretariat of WFSF, which in turn informs the Executive Committee and the Credentials Committee If there is no objection by the Credentials Committee within four weeks the applicant will be considered a full member, and must be informed

accordingly by the Secretary General

#### § 3

After having paid membership fees, every member receives a membership card which entitles him to vote in General Assemblies

#### § 4

Every member may give his authority to other members not exceeding three to vote on his behalf in General Assemblies. As far as possible voting sheets must be prepared by the Secretary General to enable absent members to participate in decisions of General Assemblies and all decision-making bodies of WFSF Voting sheets, questionnaires and other polling techniques should be used as much as possible to ensure the widest participation of all members in all proceedings and activities of WFSF

#### § 5

Lapsing of membership must be announced in a circular letter to all members quoting the related provision in the statutes

#### § 6

General Assemblies can elect an Assembly Chairman when appropriate General Assemblies can decide to elect a Secretary General and other members of the Secretariat Votes are cast by secret ballot if not decided otherwise by the General Assembly

### Add § 7

The term of the Executive Board is for two years Meetings are chaired by the President of WFSF Minutes will be taken by the Secretary General

### Add § 8

The Membership of the Scientific Council should include approximately 40 members from institutions and 20 individual members

Add § 9
Proposals for candidates for the Scientific Council must be sent via
the Secretary General to the President of WFSF Candidates representing an institution must produce a letter testifying that the candidate
represents the institution

# FUTURES STUDIES AND DEVELOPMENT STUDIES — TEN PROPOSITIONS

- 1 Future studies emerged in a situation of stability, and added dynamism producing future images different from the present. In a sense, the more stable the period and the less there happens in a country, the more future studies
- 2 Future studies, not necessarily under that heading, gained in public appeal by also producing crisis images. The crisis in the Western dominated system was converted into, and presented as a resource crisis, local scarcities were seen as global scartities.
- 3 Since about 1973 this changed the profound dynamism of the Third World spread to the First (and probably also the Second) world

under the heading of "oil crisis" — and more particularly and significantly under such headings as Indochina and Watergate

Dynamism became too high rather than too low, present studies seemed more relevant than future studies, activities now and here more valid than thinking and experimenting about the future

- 4 But in this situation future studies should became *more* relevant than ever The need for alternatives, for visions, for ideas no longer as an intellectual and scientific game or as artistic performance, but as dire necessity particulary to help avoid regressive, even fascist responses to our predicament
- 5 Global interdependence before development studies were for the Third world, and about them (done by us), and future studies were for us and by us Increasingly these two fields of disciplined study will now have to merge and produce a less schizophrenic approach to the human condition. The poor countries also to study the rich
- 6 One basic reason for this is the underdevelopment/overdevelopment dialectic. One used to see development as a Third. World problem, the perspective should now be that we are all maldeveloped, only located on different sides of the social optimum Moreover, the two worlds are interdependent through increased use of self-reliance the fight against underdevelopment will affect the rich and industrialized world profoundly, and produce conditions under which a struggle against overdevelopment becomes more meaningful 7. Orientation towards needs the thinking about development, and less so about the future has often been thing —, structure-system-oriented. The plea should be made for a return to the basic unit, the human being and our needs material as well as immaterial. They are all fundamental, not only food, clothes, shelter, health and education.
- 8 The idea of a social minimum or floor in the poor parts of the world, of a social maximum of ceiling in the rich part
- 9 The idea of alternative life styles in rich countries as a major research field within future studies as our contribution in the development studies/future studies alliance
- 10 A plea for optimism problems can be solved our task is

not to contribute to facile pessimism but to solutions

## 5th WORLD FUTURE STUDIES FEDERATION CONFERENCE

Inter-University Centre, Dubrovnik 28/3 - 2/4, 1976

The General Assembly of the WFSF decided at the proposal of the Executive Committee to hold the next World Conference at the Inter-University Centre in Dubrovnik

The themes of the conference will be

"World alternative systems versus needs"

Education in the Future, education towards the future In addition to this there will also be two "open days" It is proposed to devote the mornings to plenary sessions and the afternoons to working groups, for instance 3 or 4 for each theme In addition the agenda will include the General Assembly of the WFSF

The IUC facilities include a conference hall with a seating capacity of 200, easily expanded to 300 because of a removable wall With the experience of the three preceding conferences it should be sufficient — we might also indicate an upper limit on the registration in the letter of invitation

In addition to this there will be four of five large working-group rooms (with a seating capacity from 30 — 60) available, and six to eight smaller rooms (capacity five to eight persons), all of this in the same building coffee and other refreshments will also be a vailable. The Executive Committee found the facilitities satisfactory, and since the Inter-University Centre will benefit from the conference by making use of some of the participants as resource persons in two of the IUC courses (one of them being organized in cooperation with the WFSF, as this year's Future Studies course, for next year referred to as "Models for the Future Domestic and Global")

Nevertheless, a registration fee should be charged (25 dollars, 10 dollars for students or the equivalent in foreign currency) to help cover administrative expenses in the preparation of the conference

WFSF will not be in a position to copy papers, and such facilities will not be available during the conference period Participants, hence are required to bring as many copies of their own papers as they want to have distributed

It is hoped that much spontaneous group formation will take place during the conference, and it is suggested that only a few of the working groups will be preplanned in any way

Participants are expected to see to accommodation themselves, making direct arrangements with the hotels. There is one hotel (Imperial) only a few minutes from the IUC; and two other hotels (Lero and Libertas) at walking distance from the IUC (15 minutes). Accommodation with full board costs about \$ 10 - at the Imperial, \$ 7 - at Lero and \$ 15 - at Libertas (rates subject to change, but since the conference will be in the inexpensive seasons the rates will still be very low). It is highly recommended for participants to enquire early into the possibilities of cheap package tours, group travel, etc

Preregistration will be directly to the WFSF secretariat, in Rome and final registration upon arrival in Dubrovnik
